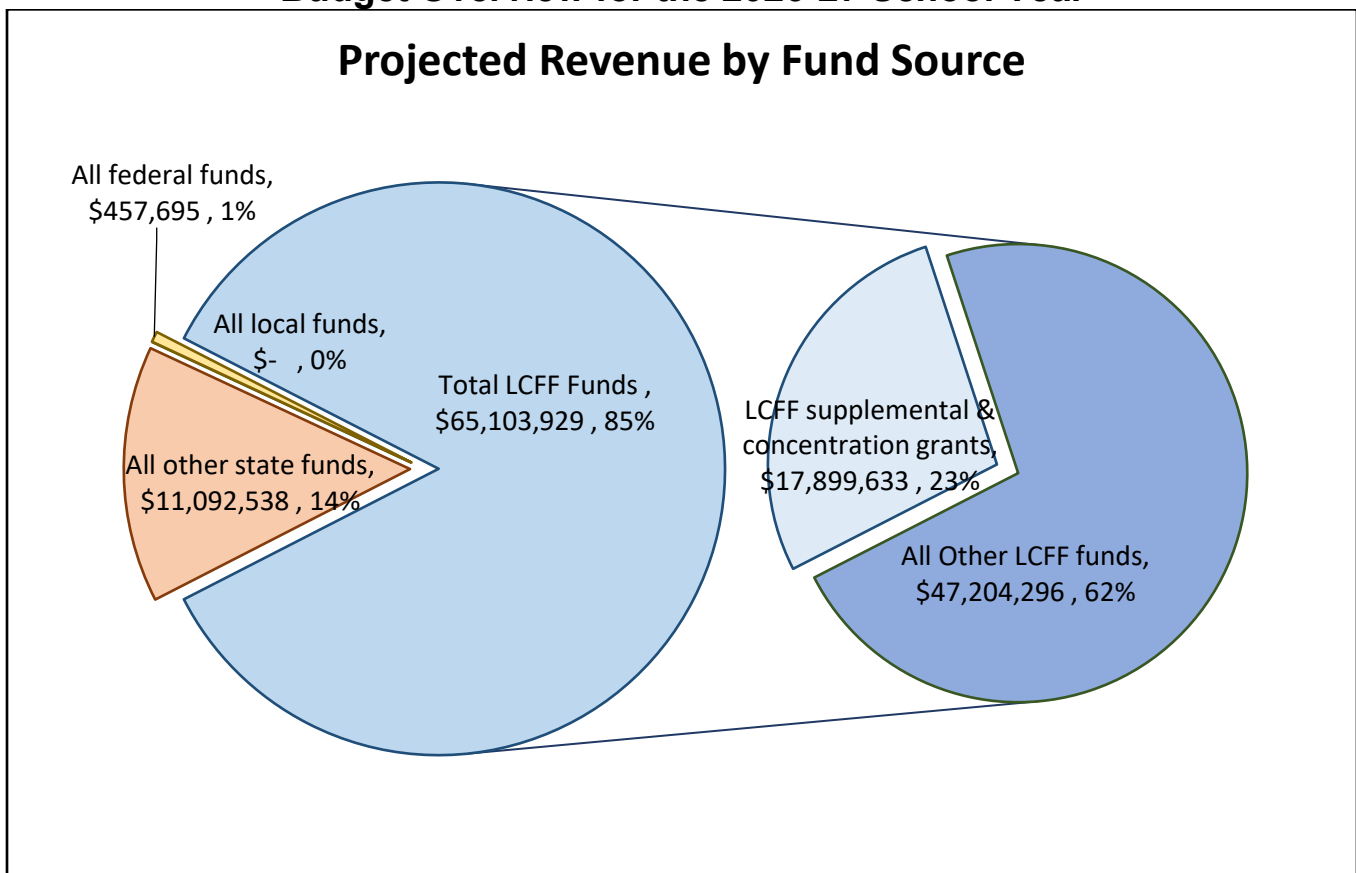

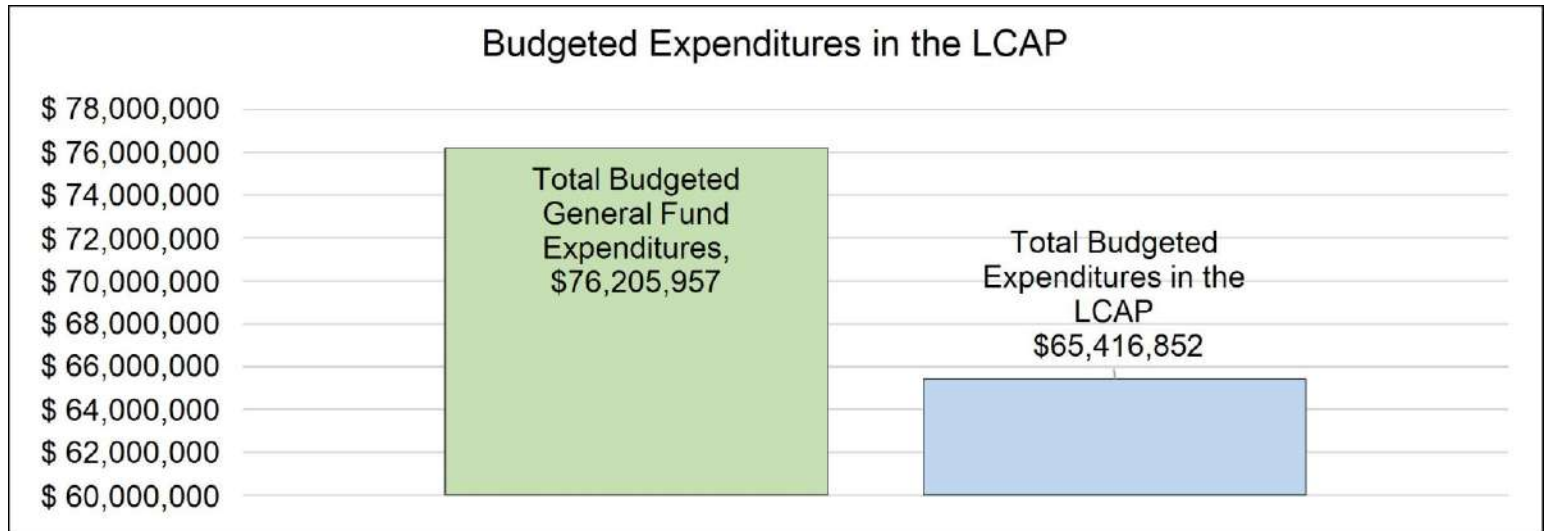


This chart shows the total general purpose revenue Assurance Learning Academy expects to receive in the coming year from all sources.

In 2026-27, Assurance Learning Academy is projecting it will receive \$17,899,633.00 based on the enrollment of foster youth, English learner, and low-income students. Students have access to a robust tutoring program that supports their learning. Targeted academic interventions help close skill and knowledge gaps, ensuring that students become competent graduates. Our second goal is a broad goal supporting student interest in a career or higher education. 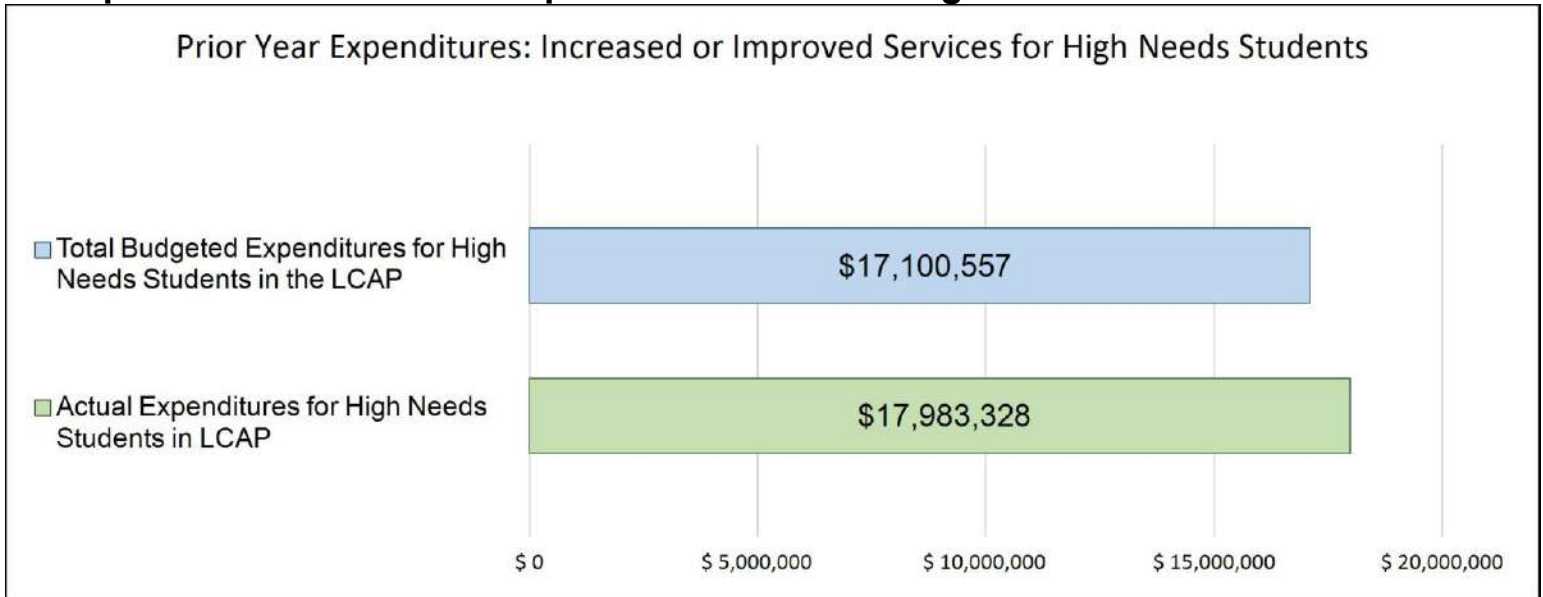

Plan Summary [2026-27]

General Information

Assurance Learning Academy (ALA) is an independent study charter school with Dashboard Alternative School Status (DASS), serving 3014 students across Los Angeles County. Our diverse student population includes 14.6% English Learners, 86% socioeconomically disadvantaged students, 1.7% foster youth, and 20.3% students with disabilities. ALA provides an alternative educational pathway for students who have disengaged from traditional classroom settings or seek a more personalized learning experience.

Recognizing the ongoing challenges of housing insecurity, economic hardship, and social-emotional needs our independent study model offers flexibility for students balancing work, childcare, or other responsibilities. We serve a broad range of learners, including those needing credit recovery, English language support, or an alternative curriculum structure better suited to their needs.

Our instructional approach includes site-based learning, independent study, small-group instruction, and one-on-one support. We emphasize high academic and behavioral standards, student resilience, social-emotional learning, and increased parental involvement. ALA's 334 dedicated staff members design personalized learning plans tailored to each student's needs, ensuring meaningful engagement and academic success.

As a year-round, credit recovery program, we prepare students for college and career readiness through integrated job-readiness coursework and Workforce Innovation and Opportunity Act (WIOA) partnerships. These partnerships connect students—especially at-risk and out-of-school youth—to career pathways and workforce training, aligning their education with real-world job opportunities.

Reflections: Annual Performance

A reflection on annual performance based on a review of the California School Dashboard (Dashboard) and local data.

Reflections: Successes

We analyzed our school data using the CA Dashboard, DataQuest, our SARC, and our LCAP Annual Data Report, which aligns with the 8 state priorities. Although the school is identified for Comprehensive Support and Improvement (CSI), due to the federal graduation rate, and for Differentiated Assistance for student groups in the red, there were significant successes as shared in the key metrics below.

Graduation Rate

Our CDE Dashboard Alternative School Status (DASS) Graduation rate was calculated at 90.0%. This is high for a DASS school serving students who enroll needing more than +30 credits to graduate on average. This is a +16.4 point increase from the baseline year. 92.0% of our English learners graduated in 2025. Also, above the All-student groups were foster youth at 100% and White at 91.3%. Additionally, our students with disabilities graduated at 89.2%, and were just below the All group. Our African American students graduated at 88.6%, and our Hispanic student group graduated at 89.4%, which is just below the All-student group. Low-income and homeless groups were also just below the All-student group at 90.0% and 87.3%, respectively. This shows that our mission of meeting students' academic and social-emotional needs was effective. We plan to increase our success with our students by increasing tutoring support, for all seniors.

Attendance

Our attendance rate is high at 89.08% and is +4.08 percentage points above our expected outcome of 85%, and +1.08 above the baseline. We believe that the re-engagement strategies that we implemented, to help students and families during the crisis, also contributed to increasing the students' average attendance rate. Our teachers and retention support staff collaborate to ensure that all students stay enrolled in school and have regular attendance.

Non-Completer Rate

Our non-completer rate is 9.53%, which is still below our 10% internal threshold. There was a slight increase of +2.77 from the baseline year. This metric was recalibrated to be an end-of-year measurement, which resulted in a slight increase. Our teachers and retention support staff work to address the serious concerns we have for students potentially dropping out. Building relationships and staying connected with students has kept the non-completer rate low.

Success Rate

Another important measure for us is our success rate, which is the percentage of students who graduate, along with the percentage that are retained or returned to their local school district. Our success rate was 90.47 as of LP7 which is +9.5 percentage points above the target outcome. This metric was recalibrated to be an end-of-year measurement. It's been high over the last three years and shows that our mission of meeting students' academic and social-emotional needs continues to be effective.

Credit Completion

Our credit completion rate is a very important local metric that helps to monitor progress towards graduation. It has increased over the last two years. With additional supports in place, such as tutoring, our students increased their credit completion significantly, with overall growth of +1.37 credits, on average +34% more, per learning period compared to baseline, and notable gains across student groups. Our low-

income students earned +15% higher credit completion rate than the previous year. Students in the low-income and special education groups earned +1.33 and +1.05 points higher, respectively, in credit completion compared to their baseline year. The foster youth student group also increased slightly by +.20. The English learner group was +.38 points and above the All-student group. We expect to continue to increase our credit completion rates for all students so that they stay above 4.0 or higher each learning period.

Science CAASPP and CA Dashboard

The CAASPP Science scores also showed that 19% of our high school students were meeting or exceeding standards. This was about a +6% points increase from the previous year, and we are making progress towards our outcome of 26%. Our low-income students were at 14%, and Hispanic students were at 19%. White students were at 16%, and homeless students scored at 7%. Other student groups were below or not enough to warrant a calculation. The CA Dashboard shows a green status for science. We serve students who are traditionally 3-4 grade levels behind in their schooling.

Suspension and Expulsion Rate

Suspension rate was blue, which is “Very Low” on the CA Dashboard. It was 0.1% for the All-student group. The two or more races group was green. English learners, LTELs, African American, Hispanic, and low-income students had a blue status. Our foster youth, homeless, Asian, Filipino, and all other students had 0% suspensions. Expulsions were low at 0.02%.

School Survey Results

Our school survey data shows that 98% of our students felt connected this year. This is the same as last year and is over our expected outcome. This is an important metric for us, and we expect it to be higher each year. Face-to-face interaction with a caring adult will help students feel connected. Additionally, 99% of the students surveyed said that they feel safe at school. It is very important to us to ensure that we are doing everything possible to provide students with the time and attention to support them during their time with us. Teachers also reported that 100% are feeling safe and 100% feel connected to the school. We have high expectations for school safety and connection, and we intend to continue to improve our school connectedness.

Parents are encouraged to participate in their students’ education as well as school activities, events, and celebrations. While overall participation in PAC and ELAC meetings has declined compared to previous years, survey data shows that 98% of parents feel encouraged to participate. This is a +12 point increase from the previous year.

How will we maintain our success?

We plan to maintain and build on our success by implementing our LCAP actions with fidelity, carefully monitoring our progress, and discussing our results within our professional learning community (PLC). We will continue to grow in our capacity as we engage in a process

of continual improvement based on the Plan-Do-Study-Act model (PDSA). Ongoing data discussions between teachers and administration will be grounded in established (PLC) protocols, with a focus on improving student outcomes. These regular PDSA cycles of collaboration will ensure continued alignment with and commitment to our LCAP actions.

The goals and actions articulated in our LCAP support our personalized learning model and adequate funding is provided to ensure that effective strategic supports such as tutors, student retention services, and trauma-informed trained teachers continue. We monitor the progress of our students through multiple measures around engagement and academic performance. LCAP data and other local data are discussed quarterly and shared with our educational partners, including the school board.

Due to the nature of our credit recovery, independent study, and Dashboard Alternative School Status (DASS) program, certain data points are not included in the LCAP. Students do not take Advance Placement, or pass EAP in any amount greater than 11, and the CDE prohibits any potentially identifying student data. The federal calculation for the 4–5-year cohort graduation rate and the chronic absenteeism rate metrics are also not a match for our program, because the calculations are for seat-based programs and not short-term independent study programs that have students with high mobility. We utilize alternative metrics such as the one-year DASS graduation rate and local attendance rates to monitor and report our students' progress towards graduation. Furthermore, our dropout rate is calculated as our non-completer rate, which tracks any student who does not report to us that they have continued with another program to complete their education.

Reflections: Identified Need

Our school is participating in Differentiated Assistance, and we are working with county experts. We did a robust needs analysis for student groups in the red on the CA Dashboard. We also used additional data State and local metrics to identify student groups' performance gaps and resource inequities. We used student outcomes data from the latest CA Dashboard, DataQuest, CALPADS reports, and local LCAP data tracking. The data shows that multiple areas must be addressed as goals and actions in the LCAP. Our internal data collection and reporting system uses metrics that are aligned with state indicators and local performance indicators. We regularly monitor and evaluate our identified outcomes, so that we can make program adjustments in areas that require improvement. As a professional network, we used a fishbone protocol for our needs assessment around our low graduation results. This revealed that multiple causes play into the graduation rate that needs to be managed, such as credit completion, attendance, student motivation, parent engagement, and tutoring.

Our school was identified for Comprehensive Support and Improvement (CSI), as the result of a low federal 4–5-year cohort graduation rate. Each year we engage in a cycle of improvement and examine the school data to determine if we will need to take action in the areas of graduation, credit completion, EL reclassification, and academic indicators by increasing tutoring support for students who are in line to graduate. This section describes our needs assessment to meet the federal requirement for CSI.

State performance indicators from the California School Dashboard show the following indicators were very low:

5-Year Cohort Graduation Rate

The federal 4–5-year cohort graduation rate is very low and qualified us for CSI. The 5-year graduation rate was 36.9% in 2025, 28.8% in 2024, and 25.4% in 2023. This is far below the 68% threshold, but it is an increase of +8.1 points. The student group data used in our

analysis is from the Dashboard and is also reported in DataQuest. Our Hispanic students were at 34.0% and they increased by 7.6 points. Our African American student group was at 25.8%. The White student group was above the All-student group at 57.3%. The homeless group was at 25.5%, and the foster youth group was a 35.6%, which is close to the All-student group. Additionally, our socioeconomically disadvantaged were at 36.5% and increased by 8.4 points. English learners and LTELs were 36.9% and 29.4%, respectively. Students with disabilities were at 32.5%, just below the All-student group. There were not enough students in the following groups to warrant a performance color for Asian, two or more races, and Filipino. We recognize the inequities between the highest student group and the other student groups, and our plan to address the gap in graduation scores is outlined in our CSI plan and the LCAP.

English Learner Progress

The CA Dashboard ELPI is red and shows 27.1% making progress towards English. This is a decline of -4.5% points from the previous year. Our LTEL group was red, showing 34.3%, maintaining progress. Our expected outcome is moderate growth. However, our English Learner reclassification rate was almost double from the previous year at 13%. English Learner Progress Indicator shows that the state average was 46.4% of all EL students who made progress last year. We hope to meet that soon.

CA Dashboard English Language Arts

Our Academic Indicator for English Language Arts showed the All student group performing at 75.7 points below standard and received a red status. This was a slight decrease from the previous year at -1.7%. Our Hispanic student group was red, with a decrease of 1.4 points. The White student group declined by 9.2 points and was in the red, along with the African American student group, which decreased by -3.4 points from the previous year. English learners also decreased by 8.1 points. Maintaining their red status were our English learners, students with disabilities, and low-income student groups. Homeless and LTELs were in the orange status with increases above 14 points. Our American Indian, Asian, Filipino, foster youth, and all other groups did not have enough students for a status to be calculated.

CAASPP English Language Arts

The CAASPP scores also showed that 23% of our 11th graders were meeting or exceeding standards. This was the same as the previous year with 23% and is still below the expected outcome. Most of our students come to us deficient in credits and skills, and they score at the 7th-grade level in ELA. Hispanic students scored above the All-student group at 26%. The student groups who were below the All-group were homeless at 9%, students with disabilities at 7%, and White students at 11%. Above the All-student group were foster youth at 27%. African American students were at 16%. Our English learner group was at 2%. Other groups did not have enough students for a calculation. This is because we serve students who are traditionally 3-4 grade levels behind in their schooling.

CA Dashboard Mathematics

The Academic Indicator for Mathematics for the All-student group is a red status, and it declined by 3.5 points from the previous year. The All-group was below standard by 183.8 points. Our English learner and White student groups declined by about 10 points. The LTELs were orange and increased by 7.3points. Maintaining their red status were our African American, Hispanic, homeless, students with disabilities, and socioeconomically disadvantaged students. declined by -6.8 points. Our American Indian, Asian, Filipino, foster youth, and all other student groups did not have enough students to warrant a calculation. There were no other groups that were two or more performance levels below the "all student" group.

CAASPP Mathematics

Our 11th graders scored 3% meeting standards on the CAASPP for Mathematics. This is the same as the previous year. Low-income and Hispanic student groups scored at 3%. African American students were at 5%, which is just above the All-student group. Our White student group and Asian students were above the All-student group at 3% and 17%, respectively. English learners and students with disabilities were at 1% proficient. All other student groups did not have enough students to warrant a calculation. This is because students who enroll with us are typically 3-4 grade levels behind in their schooling.

Retention Rate

One critical focus of our program is to improve the performance of our disengaged students and address social-emotional concerns such as trauma. We identify, early on, which students are not completing their schoolwork and then assign them tutors to ensure that they help support student learning. This metric was recalibrated to be an end-of-year measurement. In 2025, our retention rate was 73.34%, which is - 14.11 percentage point growth compared to the baseline year. We know this can improve with the collaborative teamwork between our teachers, tutors, and counselors.

College and Career Indicator: African-American, English learner, Hispanic, foster youth, homeless, socioeconomically disadvantaged, students with disabilities, and White.

Reflections: Technical Assistance

As applicable, a summary of the work underway as part of technical assistance.

Reason for Technical Assistance:

Initially, our collaborative CSI/DA improvement team analyzed the 2023 CA Dashboard Academic Performance Indicator results and identified the student groups in the red were our African American, English Learners, foster youth, Hispanic, homeless, socioeconomically disadvantaged, and White students. As part of receiving technical assistance, our school began to work with the Los Angeles County Office

of Education. Our CSI/DA team received training and did a needs assessment to identify root causes. Our action plan aims to address the social-emotional needs and academic challenges of special population students through the development of a comprehensive support system, including regular assessments, counseling programs, and specialized curriculum.

Summary of the work underway as part of receiving technical assistance:

This year, our CSI/DA improvement team of eight educators attended a training with the Los Angeles County Office of Education, which was instrumental in helping us use data more effectively to drive student growth. This year, as part of our technical support, we analyzed the 2024 and 2025 CA Dashboard Academic Performance Indicator results. We identified key student groups in need of improvement, especially for our Hispanic student group. Our LCAP Action 1.2 supports differentiated assistance, as the school continues to implement evidence-based interventions designed to improve student achievement, particularly for the Hispanic student subgroup. Additionally, during all-staff professional development, all departments identified how they can support improving Dashboard outcomes based on their specific scope of work. Staff reviewed student group performance data in ELA and Math and determined targeted areas where they can focus their efforts to contribute to growth. Strategies included structured small group instruction, high-dose tutoring, and curriculum supports focused on essential ELA and math standards. Staff collaboration and progress monitoring meetings have been used to adjust instruction and ensure consistent implementation across classrooms.

Moving forward, one key next step will be the continued implementation, monitoring, and refinement of our MTSS framework to enhance our comprehensive approach and strengthen a system of continual support and improvement.

Support for Identified Schools

We are a single-school LEA with Dashboard Alternative School Status (DASS). This is a summary of how we supported ourselves in the development of the Comprehensive Support and Improvement Plan. With guidance and training from the CDE, the county, and our local professional network, we did the following:

- We assigned our State and Federal Programs coordinator to provide leadership for the school in conducting a needs assessment. By analyzing the 2023, 2024, and 2025 CA Dashboard 5-year cohort graduation data to identify gaps and inequities between the highest student group and the other groups. The results are described in the Identified Needs section in the LCAP Plan Summary. Our framework is based on Carnegie's Improvement Science, and our model is the Plan-Do-Study-Act process for achieving continual improvement.

- The type of data collected for the needs assessment was CA Dashboard, math, ELA, and graduation results, attendance data, tutoring participation data, and credit completion data.
- The data informed the CSI plan by guiding the root cause analysis towards intensive tutoring, as a viable research-based strategy that would increase student math skills, credit completion, and therefore graduation rates. The data revealed that students who participated in tutoring earned more credits than those who did not. As a result, Goal 1 Action 3 in the LCAP provides for intensive tutoring.
- The educational partners were engaged in the process through meetings held by leadership, sharing the data, and eliciting consultation from ELAC, PAC, staff, and student groups. Our discussions centered on equity for all students with regard to learning expectations, obstacles to achieving their potential, and access to quality materials and instructional support, such as tutoring. Additionally, as a professional network of DASS independent study schools, we reviewed graduation data using the fishbone protocol. This helped to reveal root causes. A deeper dive was done with the fishbone protocol with our admin team around credit completion rates, and the potential resource inequities questions helped frame our analysis. We then engaged our educational partners, PAC/ELAC parents, students, teachers, classified, and administration, in the analysis of the data. This led to their support for Goal 1 Action 3, which assigns intensive tutoring to students as a means to improve the graduation rate.

Evidence-Based Intervention – Intensive Tutoring

The State and Federal Programs coordinator supported the school by leading the principal's team through the needs assessment, identifying the evidence-based strategies, and then leading the school improvement team through the selection of evidence-based strategies at their team meeting.

The process for matching the selected intervention with the identified need was a collaborative endeavor through our professional network. We met regularly to study the data. From our needs assessment, we saw that those who attended tutoring earned 50% more credits, and we came to believe that tutoring could potentially close credit completion gaps. We then investigated other best practices for improving graduation.

The California Department of Education (CDE) and the California Collaborative for Educational Excellence (CCEE) provide evidence-based research focused on high-impact tutoring (also known as high-dosage tutoring). Their resources emphasize that tutoring is one of the most effective interventions for accelerating learning, particularly for students performing below academic thresholds. With guidance from CDE and county offices, we searched for solutions to improve our graduation rate, and we were guided to the following evidence-based research. In determining the selection of strategies to improve graduation, we considered and identified the following evidence-based research interventions from these sources:

- The CCEE, in partnership with J-PAL North America (MIT), provides a "Learning Path" on implementing evidence-based tutoring. Key Principles of Effective Tutoring: The CCEE highlights that to be effective, tutoring should be:
- o High-dosage/Frequency: Three or more sessions per week.

This research on math tutoring, using a randomized controlled trial, involved 2,718 males in the ninth and tenth grades, from the south and west sides of Chicago. They were 90% on free and reduced lunch programs, and 95% were either African American or Hispanic. They demonstrated an increase in math scores by 0.19 to 0.31 standard deviations, as well as increases in math grades by 0.50 standard deviations. The positive impact of tutoring is also supported by the meta-analysis of the studies listed above, with one study in particular stating that there was an effect size for this practice above a 0.33 standard deviation (Nickow, Oreopoulos, Quan, 2020). This is a match for our demographics as well.

The intervention was chosen for three main reasons. First of all, our students are very low in math skills, which inhibits their capacity to earn credits towards graduation. Second, education research points to intensive tutoring as a viable means to increase math performance, which in turn will increase credit completion. Third, increasing students' capacity to earn credits through intensive tutoring will yield higher graduation rates.

Therefore, our professional network team and our educational partners selected the following research-based strategies to implement:

- * We will provide one-on-one intensive tutoring in math, ELA, and other core subjects as needed.
- * We will provide positive social incentives for good attendance.
- * We will track specific data for our seniors through site teams of teachers, counselors, and student retention support staff.
- * We are going to continue seeking educational partner involvement and input.

We will address the low performance in the areas of graduation, ELA, and mathematics by assigning intensive tutoring to students who demonstrate low scores as determined by their NWEA diagnostic results. These low scores reveal that there are inequities that must be resolved through the implementation of our plan.

Resource Inequities Analysis (Based on data using the 2023, 2024, and 2025 Dashboards as stated in the Reflections – Annual Progress section)

The State and Federal Program coordinator provided guidance to the school through a resource inequities analysis. This showed that more funds should be directed into LCAP Goal 1 Action 3, because the following groups had significant gaps between the highest student group's graduation rate and other student group rates. Specifically, almost every group was below the White student group in their 4-5 year graduation rate. The 2025 CA Dashboard shows the White student group was above the All-student group at 57.3%. Our Hispanic students were at 34.0% and our African American student group was at 25.8%. The homeless group was at 25.5%, and the foster youth group was a 35.6%, which is close to the All-student group. Additionally, our socioeconomically disadvantaged were at 36.5% and increased by 8.4 points. English learners and LTELs were 36.9% and 29.4%, respectively. Students with disabilities were at 32.5%, just below the All-student group. This shows that student groups had a gap of about 20-32 points from the highest student group. This data shows that there are inequities in performance, and our LCAP with its CSI plan is designed to address them in a comprehensive manner with research-based strategies such as intensive tutoring.

We are a charter school, and as a single school LEA, we do not take the federal CSI funds because the LCFF funding for our LCAP is sufficient. Our State and Federal Program coordinator provided support by discussing with school leadership to address the resource inequities and analysis, and agreeing to increase the funding for LCAP Goal 1 Action 3. The guiding framework was from The Alliance for Resources Equity at www.educationresourceequity.org. We also used the Dimensions of Resource Equity – School-level Diagnostic Questions to determine key resource levers that create equitable learning experiences for all students.

Additionally, the inequities rubric, provided by the Los Angeles County Office of Education, was used to help identify if there were any barriers to the following:

- Access to Highly Qualified Teachers
- Access to Counselors
- Access to Student Retention Services
- Access to Tutors
- Access to Interventions, both social-emotional and academic
- Access to Incentives for attendance, graduation, and retention
- Access to Support for high needs English Learners, foster youth, special education, and homeless

- Access to Technology and instructional materials

The resource inequities are being addressed by using LCFF funds to adequately support our LCAP Goal 1 Action 3 for intensive tutoring. This goal provides funding for the tutoring support that will be provided to students as the action is implemented at the school site. Students are identified for tutoring based on NWEA diagnostic results, teacher referral, and self-referral. Tutors connect with students daily and provide academic support in math and other subjects to help students learn and earn credits towards graduation.

All of our students receive a personalized learning program that is unique to each student and is specifically designed to create an optimal path toward graduation. The independent study model assigns a supervising teacher to each student, who develops a close relationship with the student, supports the student from enrollment to graduation, and brings in resources and support staff as needed. Furthermore, the framework for guiding our process was based on Improvement Science in Education from the Carnegie Foundation for the Advancement of Teaching (2015). The Plan, Do, Study, Act (PDSA) model, when done frequently and in collaboration with a network will help our school improve its outcomes on multiple metrics. Through our professional network, we used a fishbone protocol to determine root causes behind the conditions and drivers that lead to the outcome of a graduation metric. This helped us to define the problem we would like to address. Our discussion focused on what changes we wanted to introduce and why. We plan to collect and share data regularly around credit completion, attendance, and senior graduation progress to help answer the question: “How will we know which change is an actual improvement?”

The Six Principles of Improvement from the Carnegie Foundation helped provide a foundation for our analysis:

- 1) Make the work problem specific and user-centered: What specifically is the problem we are trying to solve?
- 2) Variation in performance is the core problem to address: What works, for whom and under what set of conditions?
- 3) See the system that produces the current outcomes: What are the drivers that yield change?
- 4) We cannot improve at scale what we cannot measure: What are the key outcomes that track progress?
- 5) Anchor practice improvement in disciplined inquiry: How will we engage in rapid cycles of Plan, Do, Study, Act (PDSA)? “How will we know which change is an actual improvement?”
- 6) Accelerate improvements through networked communities: How can we accomplish more together?

These guiding principles will be utilized in our professional network throughout the year as we meet to discuss progress and next steps.

Monitoring and Evaluating Effectiveness

A description of how the LEA will monitor and evaluate the plan to support student and school improvement.

The State and Federal Programs coordinator will support the school team and work with them in monitoring and evaluating the effectiveness of their improvement plan throughout the school year.

The process, including metrics, used for monitoring the implementation of the CSI plan is that the State and Federal Programs coordinator will collaborate with the school team to collect tutoring participation data and share it with teachers and school leadership. This will be done every learning period (which is four weeks).

The process, including metrics, used for evaluating the implementation of the CSI plan is to pull tutoring participation counts every learning period and determine if there is an increase in those who have received tutoring. The target is to increase tutoring participation by 50% at the end of the 7th learning period.

The process, including metrics, used for monitoring the effectiveness of the interventions to improve student outcomes, is to pull and analyze credit completion for all students who participated in tutoring. This will be done every learning period.

The process, including metrics, used for evaluating the effectiveness of the interventions to improve student outcomes, is to analyze the credit completion data to determine if it has increased. The target for the credit completion rate is 4.0 credits per learning period. Additionally, we expect that the graduation rates will increase by at least 1% each year.

Additionally, we will collaborate with our professional learning community network and implement the Plan-Do-Study-Act (PDSA) model as our process for continuous improvement. Through a collaborative team of school educators, we will use school data, such as tutoring participation, credit completion rates, attendance, and graduation rates, to inform our inquiry and help focus on results. By monitoring our evidence-based interventions, we can see how seniors and others are utilizing the one-on-one tutoring and social incentives for good attendance. We will also continue to monitor our key metrics, such as credit completion rates and NWEA results, to identify the needs of struggling students who could benefit from additional one-on-one tutoring.

Again, the measure of success for the plan will be based on key indicators such as credit completion, attendance, tutoring contacts, the DASS one-year graduation rate, and the federal 4-5 year graduation rate. Since each student is assigned one-on-one time with an individual teacher, all students who are identified in the system as 12th graders are monitored closely by their teacher for progress toward graduation. Completed coursework and credits earned are monitored every learning period. In addition, counselors monitor all seniors for credits earned. We plan to monitor students early and often so that we can be proactive in responding to students' academic needs. We also plan to do the following: provide support staff to work with students falling behind regularly to address their specific needs; ensure that students in need participate in tutoring with a tutor they can connect to regularly; and promote participation in small group instruction when possible. To help ensure that we have the whole school community mobilized to support our Comprehensive Support and Improvement plan, we will report results back to teachers, students, parents, and the school board. We will share our progress on our CSI plan at least twice a year. We can build the capacity of our Parent Advisory Committee (PAC) and English Learner Advisory Committee (ELAC) by sharing the school data progress with them at their meetings and eliciting their feedback as part of our PDSA model. Our school board learns about student progress towards graduation regularly, but with the CSI plan in place, we will ask for their feedback and input as part of our process. We have regular data reports that we can share with teachers and parent groups throughout the year, and we will continue to collaborate and celebrate as students make progress towards graduation.

A description of how the adopted LCAP was influenced by the feedback provided by educational partners.

The 2026–2027 LCAP was developed through a collaborative and interactive process with educational partners, ensuring that goals, actions, and LCFF fund allocations reflect student needs identified through data, local indicators, and ongoing feedback. Communication throughout the year remained two-way, open, and supportive, allowing parents, students, staff, administrators, and board members to actively contribute to the development and refinement of the plan.

Parents:

Feedback gathered through ELAC, PAC, parent meetings, and the Annual LCAP Survey affirmed strong support for the school’s direction. Parents consistently shared that they feel supported, heard, and confident in the care and instruction their students receive. Many highlighted a positive school environment where students feel safe, happy, and are growing both academically and personally. Overall, feedback reflects a high level of trust in the school’s staff and commitment to student success. Parents also expressed a desire to expand tutoring and academic supports, increase student engagement opportunities, and improve access to systems and resources. Parents across in-person, virtual, and charter-wide settings were invited to affirm the LREBG plan and participants expressed their agreement with a collective thumbs-up and reactions through digital spaces. These insights informed LCAP Goals 1.3, 1.5, 1.8, and 3.2.

Students:

Student voice was gathered through Student Celebrations and the Annual Survey. Students expressed a need for increased academic support, particularly in reading and tutoring, as well as a desire for more engaging and interactive learning experiences. Survey feedback also affirmed that students feel connected to staff and supported in their learning. This input directly informed Goals 1.3 and 1.5, strengthening both academic support and enrichment opportunities.

Administration:

Administrators regularly review data and metrics, engaging in ongoing discussions to address challenges such as credit completion and attendance, and to develop responsive action plans. Their work is reinforced through Annual Survey results and continued collaboration with staff and families. This input influenced Goals 1.2, along with our Differentiated Assistance collaborative work, and 1.3, along with our CSI collaborative work.

Teachers:

Staff meetings, professional development, and department collaboration provided opportunities for teachers to contribute to school improvement efforts. Teachers reported feeling valued and engaged, and their input helped shape decisions that enhance student outcomes. Feedback related to English Learner supports, experiential learning, and CTE pathways informed Goals 1.1, 1.5, and 2.1.

School Board:

Board members provided oversight through regular updates, asking thoughtful questions to ensure accountability while expressing strong support for the school's programs. They acknowledged progress in key areas, including English Learner outcomes, credit completion, and DASS graduation rates. Their engagement supported Goals 1.1, 1.4, and 1.8.

Public Input:

Opportunities for public feedback were provided during board meetings, reinforcing transparency and accountability. While no formal public comments were submitted, the process remains open and accessible to the community.

Conclusion:

The adopted LCAP reflects the collective input of all educational partners and demonstrates a shared commitment to student achievement, social-emotional well-being, credit completion, and college and career readiness. Feedback from parents, students, staff, and board members directly informed updates, priorities, and resource allocation, ensuring the plan remains responsive, aligned, and actionable.

An explanation of why the LEA has developed this goal.

As a result of our CSI status and our analysis on key state and local data, we determined the need for a focus goal on academic performance for all our English Language learners, low-income, and foster youth students. This new goal specifically addresses low key metrics such as the English Learner reclassification rate, credit completion, and graduation for our student groups. We looked at our student group data, which reveal performance gaps between the "All" Student Group, and the English Language learners, low-income, and foster youth students. Our students also take the NWEA MAP assessment, and we measure academic growth from year to year in this way. This year, performance gaps among student groups were also revealed, using that assessment. We understand the gaps that need to be closed for our students, and this focus goal was carefully designed to support their academic needs with targeted interventions and tutoring.

We sought the consultation of our educational partners, and involved them in the LCAP process, which we believe promotes positive engagement, buy-in, and trust. We know that additional tutoring, interventions, and counseling support will help address the learning loss over the next few years.

An analysis of how this goal was carried out in the previous year.

A description of overall implementation, including any substantive differences in planned actions and actual implementation of these actions, and any relevant challenges and successes experienced with implementation.

Assurance Learning Academy used the following rating scale to determine its progress in implementing the actions to achieve the articulated goal.

Ratings were based on an analysis of both input from educational partners and metrics. Rating Scale (lowest to highest): 1 – Exploration and Research Phase; 2 – Beginning Development; 3 – Initial Implementation; 4 – Full Implementation; 5 – Full Implementation and Sustainability.

Action 1.1: English Learners support staff, interventions, and materials

Implementation Status: 4 – Full Implementation

Through the integration of targeted language acquisition strategies, designated and integrated ELD instruction, and tailored instructional materials, our school continues to strengthen support systems for English Learners. EL reclassification rates remained strong at 13%, exceeding the state average, reflecting the effectiveness of these supports. While ELPI performance indicates an opportunity for continued growth, this data provides clear direction for refining instructional strategies to further accelerate language development. No substantive difference in the planned action compared to the actual implementation.

Action 1.2: All academic interventions and program materials

Implementation Status: 4 – Full Implementation

A comprehensive system of academic interventions, including tutoring, Small Group Instruction, and differentiated supports, was implemented with fidelity to address the diverse academic needs of students. These coordinated efforts contributed to strong overall academic progress, reflected in academic performance indicators such as Reading (Lexile: 934.14) and Mathematics (Quantile: 737.75) demonstrate sustained engagement in core content areas, while also providing clear direction for continued instructional refinement. The consistency and fidelity of implementation across intervention systems position the school to continue building on these gains through increasingly targeted and data-driven supports. No substantive difference in the planned action compared to the actual implementation.

Action 1.3: Tutoring and supports for students

Implementation Status: 4 – Full Implementation

Through strategic expansion of tutoring and targeted student supports, Assurance achieved significant academic gains, with average credit completion increasing to 4.04, surpassing the Year 3 target ahead of schedule. This outcome highlights the strong impact of tutoring systems and student engagement efforts. No substantive difference in the planned action compared to the actual implementation.

Action 1.4: Counseling students towards graduation and materials

Implementation Status: 4 – Full Implementation

Collaborative efforts between counselors and staff resulted in a 1-year DASS graduation rate of 90%, demonstrating continued growth and success in supporting students toward completion. These results reflect the effectiveness of personalized counseling, goal-setting, and consistent student support systems. No substantive difference in the planned action compared to the actual implementation.

Action 1.5: Student activities that increase learning efforts

Implementation Status: 4 – Full Implementation

Student engagement through enrichment activities, experiential learning, and celebrations continued to support academic progress. Course completion rates remained strong overall, with Math at 41.99% and ELA/ELD at 44.97%, reflecting continued growth from baseline levels. These efforts also supported increases in overall student learning effort, as reflected in average credit completion reaching 4.04, demonstrating strong progress toward academic goals. These efforts have contributed to increased student connection and motivation, with opportunities to further align engagement strategies to academic acceleration. No substantive difference in the planned action compared to the actual implementation.

Action 1.6: Teachers and staff are qualified and appropriately assigned

Implementation Status: 5 – Full Implementation and Sustainability

Assurance Learning Academy maintained 100% appropriately assigned teachers, demonstrating strong systems and sustainability in staffing practices. This stability continues to support consistent, high-quality instruction across the organization. No substantive difference in the planned action compared to the actual implementation.

Action 1.7: Professional Development for English Learners.

Implementation Status: Full Implementation

This action centered on providing targeted professional development to support educators in effectively meeting the needs of our EL students. Professional learning opportunities like the Teaching English to Speakers of Other Languages (TESOL) conference provided staff with professional learning opportunities to enhance instructional effectiveness. These efforts have increased staff capacity to support diverse learners. Current outcome data provides valuable insight to guide the continued evolution of professional learning, ensuring deeper implementation and impact in the classroom. No substantive difference in the planned action compared to the actual implementation.

Action 1.8: LREBG - Intervention programs and support personnel to support students

Implementation Status: 3 - Initial Implementation

ALA has received LREBG funds and is in the initial planning stages. We have reviewed student needs and analyzed relevant data to identify target areas for intervention. These funds will be used to provide additional professional development, strengthen instructional strategies and student engagement, expand tutor support, close learning gaps for EL, LTEL, FY, and LI students, and enhance intervention programs such as tutoring and small group instruction. Social-emotional supports will also be strengthened to ensure students are engaged, supported, and on track for on-time graduation.

Overall Successes

The implementation of Goal 1 actions resulted in significant and measurable progress across key academic indicators. Most notably, average credit completion increased to 4.04, exceeding the Year 3 target ahead of schedule, demonstrating the effectiveness of tutoring systems and targeted academic supports. The school also achieved a 1-year DASS graduation rate of 90%, reflecting strong counseling systems, student support structures, and a sustained focus on student persistence and success. English Learner outcomes remained a key strength, with reclassification rates at 13%, exceeding the state average, highlighting the impact of intentional language development supports and interventions. Additionally, the school maintained high levels of staffing stability and quality, with 100% of teachers appropriately assigned, ensuring consistency in program implementation. Overall, the school demonstrated strong implementation of planned actions, resulting in meaningful academic gains and positioning the organization for continued growth and success.

Overall Challenges

While the school has demonstrated strong progress, outcome data continues to provide clear direction for ongoing growth and refinement. ELPI results indicate an opportunity to further strengthen language acquisition strategies and deepen instructional practices to accelerate English Learner progress. Additionally, shifts in Lexile and Quantile performance highlight the importance of continuing to strengthen core instruction alongside intervention systems. Course completion trends reinforce the opportunity to more closely align student engagement strategies with academic outcomes to ensure consistent progress across all subject areas. These areas of growth will be addressed through continued implementation of evidence-based practices, enhanced professional development, and ongoing data-driven decision-making. Through the lens of continuous improvement with our Comprehensive Support and Improvement (CSI) and Differentiated Assistance (DA) processes, we will apply evidence-based interventions such as high-dose, one-on-one tutoring and Small Group Instruction to improve

student outcomes. The school remains well-positioned to build on its current successes and sustain upward momentum in student achievement. needs.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

There were no real material differences in the Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services, because actual expenditures were greater than budgeted expenditures and principally directed towards our English Language Learners, low-income, and foster youth students. We were able to meet our budgeted expenditures, as shown in the 2025-2026 Contributing Actions Annual Update table for estimated actual expenditures. This is true for the LCFF and LREBG funds.

A description of the effectiveness or ineffectiveness of the specific actions to date in making progress toward the goal.

Action 1.1: English Learners support staff, interventions, and materials

Effectiveness of Action: 2 – Somewhat Effective

Metric: English Learner Progress Indicator (ELPI) and Reclassification Rate

Over the three-year LCAP cycle, English Learner reclassification rates increased from a baseline of 7% to 13%, exceeding the state average and demonstrating strong progress in supporting students toward English proficiency. While ELPI performance declined to 27.1% (Red status), this data provides clear direction for continued refinement of instructional strategies and language development supports. Overall, this action has been somewhat effective, with strong gains in reclassification and a clear pathway for continued growth in EL progress outcomes.

Action 1.2: All academic interventions and program materials

Effectiveness of Action: 3 – Effective

Metric: NWEA MAP, Credit Completion

Academic interventions have demonstrated strong effectiveness across the three-year cycle. Most notably, average credit completion increased from a baseline of 2.67 to 4.04, exceeding the Year 3 target ahead of schedule. NWEA performance data, including Reading (Lexile: 934.14) and Mathematics (Quantile: 737.75), reflects sustained engagement in core academic areas and provides direction for continued instructional refinement. These results indicate that the system of interventions, including tutoring and Small Group Instruction, has been effective in improving overall student academic progress.

Action 1.3: Tutoring and supports for students

Effectiveness of Action: 3 – Effective

Metric: Credit Completion Rate

Tutoring and targeted supports have been highly effective in increasing academic outcomes. Over the three-year cycle, average credit completion rose from 2.67 to 4.04, surpassing the established goal of 4.0 credits per learning period. This growth reflects the strong impact of high-dose tutoring and targeted intervention strategies, particularly for students with the greatest academic needs. Assurance Learning Academy's CSI focus has played a key role in monitoring progress, analyzing data, and refining strategies through an ongoing cycle of continuous improvement, ensuring that tutoring remains aligned to student needs.

Action 1.4: Counseling students towards graduation and materials

Effectiveness of Action: 3 – Effective

Metric: DASS 1-Year Graduation Rate

Counseling systems have demonstrated strong effectiveness, with the 1-year DASS graduation rate increasing from 73.6% at baseline to 90%, exceeding expectations and demonstrating sustained growth over time. These results reflect the impact of personalized counseling, consistent student monitoring, and targeted graduation support strategies.

Action 1.5: Student activities that increase learning efforts

Effectiveness of Action: 2 – Somewhat Effective

Metric: Credit Completion Rate

Student engagement activities have contributed to overall academic progress, particularly in increasing student learning effort as reflected in credit completion. Over the three-year LCAP cycle, average credit completion increased from 2.67 to 4.04, demonstrating meaningful growth in student progress toward academic goals. While this growth reflects a positive impact, reflection indicates that student engagement strategies have not always been consistently aligned with academic outcomes. As a result, this action is considered somewhat effective, with a need to more intentionally connect engagement efforts to credit completion and sustained academic progress.

Action 1.6: Teachers and staff are qualified and appropriately assigned

Effectiveness of Action: 3 – Effective

Metric: Highly Qualified and Appropriately Assigned Teachers

Assurance Learning Academy has maintained strong staffing practices, with 100% of teachers appropriately assigned and consistently high levels of teacher qualification throughout the LCAP cycle. This stability has supported consistent instructional delivery and program implementation, demonstrating the effectiveness of this action.

Action 1.7: Professional Development for English Learners

Effectiveness of Action: 2 – Somewhat Effective

Metric: English Learner Progress Indicator (ELPI) and Reclassification Rate

Professional development has supported improved outcomes for English Learners, with reclassification rates increasing from 7% to 13%, exceeding the state average. However, ELPI declined to 27.1% (Red status), indicating a need for stronger and more consistent implementation of instructional strategies. This action is considered somewhat effective, with continued focus on strengthening instructional practices to accelerate English Learner progress.

Action 1.8: LREBG - Intervention programs and support personnel to support students

Effectiveness of Action: 2 - Somewhat Effective

Metric: 1.3 Reading Lexile and 1.4 Mathematics Quantile

This action supported students who struggle with academic performance by providing intervention programs and support personnel to address learning gaps. LREBG funding is directed toward academic and socioemotional interventions for all students as needed. The needs assessment substantiated findings from the 2024 Dashboard related to low academic performance in mathematics and English Language Arts. A review of state and local data, such as NWEA MAP results, indicates that students have average NWEA MAP scores of 934.14 in Reading (approximately 6th grade level) and 737.75 in Mathematics (approximately 5th grade level). This action directly addresses the need to engage students with comprehensive interventions and academic support to improve learning gaps. It aligns with the allowable uses of LREBG funds, including learning recovery programs, tutoring, and other targeted supports. Studies have shown that students who participate

in tutoring and socioemotional supports are more likely to realize gains in academic performance. Additionally, research shows that students who engage in intensive mathematics tutoring demonstrate increases in math scores ranging from 0.19 to 0.31 standard deviations. Student participation in tutoring will continue to be monitored each learning period, and NWEA scores will be used to assess performance and guide ongoing improvement.

A description of any changes made to the planned goal, metrics, target outcomes, or actions for the coming year that resulted from reflections on prior practice.

Action 1.1: English Learners support staff, interventions, and materials

Based on reflection and a collaborative analysis with coordinators and specialists, this action will be refined to address the continued need for growth in English Learner progress, as indicated by ELPI performance. While supports are in place, there is a need to strengthen the effectiveness of language development strategies. For the coming year, adjustments will include increasing participation in our ELPAC preparation courses, including targeted practice, language development activities, and progress monitoring to better support students in demonstrating growth. The school will also continue to strengthen the role of bilingual staff and intervention supports with our interpreter paraprofessional, while increasing the use of data to guide instruction and ensure that English Learners receive timely and responsive support.

Action 1.3: Tutoring and supports for students

Through regular data analysis and reflective discussions with our Comprehensive Support Improvement Team, and additionally feedback from our annual survey indicated that not all parents are aware of the tutoring supports available to students. In response, we will increase parent awareness by strengthening communication, highlighting available tutoring services more consistently, and ensuring families are regularly informed of opportunities for academic support.

Action 1.5: Student activities that increase learning efforts

Based on reflection and analysis of outcomes, this action will be refined to more intentionally align student engagement strategies with academic progress, with a focus on credit completion as the primary measure of student learning effort. Additionally, feedback from both parents and students during parent meetings and student celebrations highlighted a desire for increased experiential learning opportunities. While the school currently provides a variety of engagement experiences, the administrative team will intentionally review and refresh these opportunities to ensure they remain meaningful, relevant, and aligned with student interests. These enhancements will be designed to directly support increases in credit completion by incorporating literacy and numeracy skills into experiential learning opportunities, reinforcing classroom instruction, and increasing student motivation and engagement in core content areas.

Action 1.7: Professional Development for English Learners

Based on reflection and a collaborative analysis with coordinators and specialists, this action will be refined to address the continued need for growth in English Learner progress, as indicated by ELPI performance. While professional development has been provided, for the coming year, adjustments will include increasing the frequency and focus of professional development on English Language Development strategies. Additional emphasis will be placed on supporting staff in preparing students for ELPAC testing through structured practice, language development activities, and ongoing progress monitoring. The school will also continue to strengthen and ensure that professional learning translates into improved outcomes for English Learners.

Action 1.8: LREBG - Intervention programs and support personnel to support students

Following a collaborative evaluation and needs assessment, this action will be strengthened to better align intervention supports with identified student needs. For the coming year, adjustments will include expanding targeted intervention programs, increasing access to tutoring and small group instruction, and strengthening instructional strategies to address learning gaps. Additional professional development will be provided to ensure staff are equipped to deliver effective, evidence-based interventions. There will also be an increased focus on integrating academic and social-emotional supports to ensure students remain engaged and supported in their learning. Ongoing monitoring of student participation and performance will be used to guide continuous improvement and ensure that interventions are effectively meeting student needs.

Assurance Learning Academy used the following rating scale to determine its progress in implementing the actions to achieve the articulated goal.

Ratings were based on an analysis of both input from educational partners and metrics. Rating Scale (lowest to highest): 1 – Exploration and Research Phase; 2 – Beginning Development; 3 – Initial Implementation; 4 – Full Implementation; 5 – Full Implementation and Sustainability.

Action 2.1: Career and college-readiness for English learners, low-income, and foster youth students

Implementation Status: 4 – Full Implementation

Students were provided access to career and college readiness opportunities, including Career Technical Education (CTE) courses in Culinary Arts, Business, Music, Child Development, Professional Skills courses, and A-G aligned coursework. While participation across programs remained strong overall, fluctuations in enrollment and completion across certain programs, including Dual Enrollment and some CTE pathways, indicated a need for ongoing monitoring and refinement of student outreach and participation strategies. There was no substantive difference in the planned action compared to the actual implementation.

Action 2.2: Professional development addressing English learners, low-income, and foster youth students

Implementation Status: 4 – Full Implementation

Professional development was implemented as planned, providing staff with ongoing learning opportunities focused on supporting diverse student populations, strengthening instructional practices, and improving student outcomes. These efforts included internal professional learning for all staff, collaboration through content department learning, external conferences, and participation in county-led support learning opportunities. There was no substantive difference in the planned action compared to the actual implementation.

Action 2.3: Technology Access and Support

Implementation Status: 5 – Full Implementation and Sustainability

All students were provided access to necessary technology, including Chromebooks and hotspots as needed, ensuring full access to curriculum and instructional resources. Systems were in place to maintain device availability and respond to student needs. There was no substantive difference in the planned action compared to the actual implementation.

Action 2.4: Support for Standards-based Curriculum and Instruction

Implementation Status: 4 – Full Implementation

Standards-based curriculum and instructional practices were implemented across all content areas, supported by professional development, instructional coaching, and collaboration. The school demonstrated strong implementation of California State Standards, with continued progress toward full implementation and sustainability. There was no substantive difference in the planned action compared to the actual implementation.

Action 2.5: Educational materials for an effective program

Implementation Status: 5 – Full Implementation and Sustainability

Assurance maintained sufficient instructional materials and resources to support all students. Ongoing monitoring, inventory processes, and collaboration between instructional leaders ensured that materials remained current, accessible, and aligned to student needs. There was no substantive difference in the planned action compared to the actual implementation.

Action 2.6: Safe and Secure Facilities

Implementation Status: 5 – Full Implementation and Sustainability

Safe and secure facilities were maintained through regular inspections, staff training, and ongoing monitoring of site conditions. Systems were in place to ensure a safe learning environment for all students and staff. There was no substantive difference in the planned action compared to the actual implementation.

Assurance successfully implemented the actions within Goal 2 with fidelity. Students maintained access to a broad range of courses (100%), and standards-based instruction remained strong across content areas, with implementation increasing from 4.39 to 4.60 on the CDE Standards Implementation Rubric, reflecting continued progress toward full implementation and sustainability. Growth was also observed in college and career readiness indicators, including an increase in A-G completion from 1.7% to 4.8%, as well as continued participation in career readiness programs such as CTE and Professional Skills courses.

Overall Challenges:

While implementation remained consistent, participation and completion across programs such as CTE pathways and Dual Enrollment fluctuated over the three-year cycle, indicating a need to strengthen student engagement and access to these opportunities. Additionally, statewide assessment outcomes indicate a continued need for growth, particularly in Mathematics, where performance remains low, and both ELA and Math CA Dashboard indicators remain in Red status. These trends indicate a need to strengthen the connection between program awareness to increase participation and measurable student outcomes.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

There were no real material differences in the Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services, because actual expenditures were greater than budgeted expenditures and principally directed towards our English Language Learners, low-income, and foster youth students. We were able to meet our budgeted expenditures, as shown in the 2025-2026 Contributing Actions Annual Update table for estimated actual expenditures. This is true for the LCFF funds.

A description of the effectiveness or ineffectiveness of the specific actions to date in making progress toward the goal.

Action 2.1: Career and college-readiness for English learners, low-income, and foster youth students

Effectiveness of Action: 2 – Somewhat Effective

Metrics: CTE participation, A-G completion, Dual Enrollment

Over the three-year LCAP cycle, career and college readiness indicators showed both growth and variability. A-G completion increased from 1.7% at baseline to 4.8%, demonstrating progress in college readiness. However, participation in career readiness programs fluctuated, with CTE enrollment and Professional Skills participation varying across years, and Dual Enrollment participation increasing overall but not consistently year over year. Additionally, CTE course completion rates increased from 35.57% at baseline to 47.45%, while pathway completion rates showed modest growth. While these trends reflect positive movement, inconsistent participation across programs indicates that access and engagement are not yet fully optimized for all student groups. As a result, this action is considered somewhat effective.

Action 2.2: Professional development addressing English learners, low-income, and foster youth students

Effectiveness of Action: 2 – Somewhat Effective

Metrics: CAASPP (ELA, Math, Science), CA Dashboard

Statewide assessment data indicate incremental progress in student achievement, particularly in Science, which increased from 13% to 19%, and English Language Arts, which remained stable with slight gains. However, Mathematics performance remained low, increasing from 2% to 3%, and both ELA and Math CA Dashboard indicators remained in Red status over the three-year cycle. While professional development has supported instructional growth, these outcomes indicate that implementation has not yet resulted in consistent, measurable improvements in student performance. This action is considered somewhat effective, with a need to strengthen alignment between professional learning and classroom impact.

Action 2.3: Technology Access and Support

Effectiveness of Action: 3 – Effective

Metric: Student access to devices and connectivity

Assurance maintained 100% access to technology, ensuring that all students were provided with the necessary tools to engage in learning. This consistent access has supported student participation in coursework and instructional programs. This action is considered effective and will be maintained.

Action 2.4: Support for Standards-based Curriculum and Instruction

Effectiveness of Action: 3 – Effective

Metric: Standards Implementation (CDE Rubric)

The school demonstrated strong implementation of California State Standards, with performance increasing from 4.39 to 4.60, indicating continued progress toward full implementation and sustainability. These results reflect a strong foundation in standards-based instruction. This action is considered effective, with continued focus on reaching full implementation across all areas.

Action 2.5: Educational materials for an effective program

Effectiveness of Action: 3 – Effective

Metric: Access to instructional materials

The school maintained consistent access to high-quality instructional materials, with 100% access to a broad range of courses for students across the LCAP cycle. This action is considered effective and will be sustained to support continued student learning.

Action 2.6: Safe and Secure Facilities

Effectiveness of Action: 3 – Effective

Metric: Facility Inspection Tool (FIT), School Climate Data

Facilities remained safe and secure, with strong systems in place to support a positive learning environment. School survey data indicates that nearly all students report feeling safe and connected at school, supporting student engagement and readiness to learn. This action is considered effective and will be maintained.

A description of any changes made to the planned goal, metrics, target outcomes, or actions for the coming year that resulted from reflections on prior practice.

Action 2.1: Career and college-readiness for English learners, low-income, and foster youth students

Based on reflection and analysis of program participation and outcome data, this action will be refined to strengthen student access to and engagement in college and career readiness opportunities. While progress has been made in A-G completion and CTE course completion, participation across programs such as Dual Enrollment and certain CTE pathways has been inconsistent. For the coming year, adjustments will include increasing targeted outreach to students and families, strengthening counseling support for course planning, and expanding awareness of available programs. Assurance will continue to leverage the College and Career Paraprofessional to promote Dual Enrollment, coordinate college and career exploration activities, and increase participation in CTE pathways. Additional efforts will focus on aligning program offerings with student interests and postsecondary goals, as well as improving tracking and monitoring systems to ensure students are progressing toward college and career readiness milestones.

Action 2.2: Professional development addressing English Learners, low-income, and foster youth students

Based on reflection and analysis from our administrative and regional teams, for the coming year, adjustments will include increasing the focus of professional development on data-driven instruction, academic interventions, and strategies to support diverse learners. Additionally, strategies learned through professional development will be intentionally implemented, monitored, and evaluated for impact on student outcomes to ensure consistency and effectiveness across all sites that lead to measurable gains in student achievement.

An analysis of how this goal was carried out in the previous year.

A description of overall implementation, including any substantive differences in planned actions and actual implementation of these actions, and any relevant challenges and successes experienced with implementation.

Assurance Learning Academy used the following rating scale to determine its progress in implementing the actions to achieve the articulated goal. Ratings were based on an analysis of both input from educational partners and metrics.

Rating Scale (lowest to highest): 1 – Exploration and Research Phase; 2 – Beginning Development; 3 – Initial Implementation; 4 – Full Implementation; 5 – Full Implementation and Sustainability.

The actions outlined in Goal Three supported the progress in meeting the following goal: Increase Student Retention.

Action 3.1: Student Retention

Implementation Status: 4 – Full Implementation

Student retention efforts were implemented as planned through a comprehensive, tiered system of support. Staff utilized proactive engagement strategies including calls, texts, emails, home visits and individualized follow-up to address barriers to attendance and participation. Collaboration across instructional and support staff ensured that students remained connected to their learning plans and received consistent encouragement toward completion and graduation. There were no substantive differences between the planned action and actual implementation.

Action 3.2: Social and Emotional Supports

Implementation Status: 4 – Full Implementation

Social-emotional supports were implemented with fidelity, providing students with access to counseling services, wraparound supports, and programs designed to foster connection and belonging. These supports contributed to a positive school climate and addressed barriers impacting student engagement. Students were provided access to Care Solace, a mental health service connecting students and families to care providers, as well as targeted supports such as Holiday Blues workshops, Parenting Students support programs, and student emotional

health seminars. These efforts expanded access to mental health resources and proactive support for students experiencing social-emotional challenges. Staff continued to build capacity through training and collaboration to better support student needs. There were no substantive differences between the planned action and actual implementation.

Action 3.3: Access to Transportation

Implementation Status: 4 – Full Implementation

Transportation supports were implemented as planned to reduce barriers to attendance. Students were provided access to transportation options based on individual need, ensuring consistent access to instructional time and school resources. These supports remained aligned with the planned action, with no substantive differences in implementation.

Action 3.4: Access to Nutrition

Implementation Status: 4 – Full Implementation

Students were provided access to meals, snacks, and additional food resources to support their well-being and engagement in school. Nutrition services were consistently available across sites, contributing to a positive and supportive learning environment. There were no substantive differences between the planned action and actual implementation.

Overall Successes:

The implementation of Goal 3 actions resulted in strong outcomes across several key indicators. The school maintained a success rate of 90.47%, exceeding the target of 80%, demonstrating continued effectiveness in supporting student completion and engagement. Attendance improved to 89.08%, exceeding the target of 85%, reflecting the impact of transportation supports and consistent student engagement efforts. Additionally, school climate indicators remained strong, with facilities rated Exemplary and survey data indicating high levels of student safety and connection. These results reflect a strong system of supports that promotes student retention and overall success.

Overall Challenges:

While several indicators remained strong, the retention rate declined to 73.34%, falling below the target of 80%. Additionally, the non-completer rate increased to 9.53%, approaching the threshold of 10%. These trends indicate a need to strengthen targeted re-engagement strategies and ensure earlier identification of students at risk of disengagement. While systems of support are in place, increased alignment between engagement strategies, attendance, and completion outcomes will be necessary to improve retention rates.

Action 3.1: Student Retention

Effectiveness of Action: 2 – Somewhat Effective

Metric: Retention Rate

The retention rate declined to 73.34%, falling below the target of 80%. While systems for student engagement and support were implemented with fidelity, these efforts have not yet translated into consistent retention outcomes. This indicates a need to strengthen early intervention strategies and improve sustained student engagement. As a result, this action is considered somewhat effective.

Action 3.2: Social and Emotional Supports

Effectiveness of Action: 3 – Effective

Metric: Success Rate

Assurance maintained a success rate of 90.47%, exceeding the target of 80%. This reflects the positive impact of social-emotional supports and wraparound services in helping students persist and complete their programs. This action is considered effective and will be maintained.

Action 3.3: Access to Transportation

Effectiveness of Action: 3 – Effective

Metric: Attendance Rate

Attendance increased to 89.08%, exceeding the target of 85%. Transportation supports have contributed to improved student access and consistent participation. This action is considered effective and will be sustained.

Action 3.4: Access to Nutrition

Effectiveness of Action: 2 – Somewhat Effective

Metric: Non-completer Rate

The non-completer rate increased to 9.53%, nearing the threshold of 10%. While nutrition supports are offered to all students, and remains an important component of student well-being, these efforts alone have not resulted in improved completion outcomes. This action is considered somewhat effective and will be strengthened through additional targeted supports.

A description of any changes made to the planned goal, metrics, target outcomes, or actions for the coming year that resulted from reflections on prior practice.

Action 3.1: Student Retention

Based on reflection and analysis of retention and completion data, this action will be refined to strengthen early identification and intervention for students at risk of disengagement. Assurance will enhance tiered re-engagement strategies, increase proactive communication with students and families, and improve tracking systems to monitor student engagement and progress. Additionally, the Student Retention team will meet regularly to review strategies, analyze student data, and identify students with the greatest need for support. These collaborative meetings will ensure timely interventions, strengthen alignment across staff, and support more consistent outcomes in student retention and completion. This metric was updated to be an end-of-year measurement.

Action 3.2: Social and Emotional Supports

This metric was updated to be an end-of-year measurement.

Action 3.4: Access to Nutrition

While nutrition supports are available to 100% of our students, this will be integrated into a broader system of wraparound services. Additional coordination of services will be implemented to better support students at risk of becoming non-completers. This metric was updated to be an end-of-year measurement.

Assurance Learning Academy used the following rating scale to determine its progress in implementing the actions to achieve the articulated goal. Ratings were based on an analysis of both input from educational partners and metrics.

Rating Scale (lowest to highest): 1 – Exploration and Research Phase; 2 – Beginning Development; 3 – Initial Implementation; 4 – Full Implementation; 5 – Full Implementation and Sustainability.

The actions outlined in Goal Four supported the progress in meeting the following goal: Increase Educational Partner Engagement.

Action 4.1: Community/Parent Liaison and Meaningful School Activities

Implementation Status: 5 – Full Implementation and Sustainability

Assurance implemented a variety of activities to promote meaningful engagement with families and the community, including orientations, back to school nights, open houses, parent conferences, and PAC/ELAC meetings. These events were designed to provide multiple opportunities for families to connect with the school and actively participate in their student’s educational experience. Participation in school events remained strong, with 2,769 total participants compared to an enrollment of 2,843, demonstrating continued engagement across the school community. These efforts were implemented as planned, with no substantive differences between intended actions and actual implementation.

Action 4.2: Translation and Outreach Services

Implementation Status: 5 – Full Implementation and Sustainability

Translation and outreach services were implemented to ensure all families had equitable access to information and opportunities for engagement. Bilingual staff, translated materials, and interpretation services were provided during meetings, conferences, and school

events. These efforts supported increased accessibility and participation among families of diverse linguistic backgrounds. Implementation aligned fully with the planned action, with no substantive differences observed.

Action 4.3: Educational Partner Engagement

Implementation Status: 5 – Full Implementation and Sustainability

Assurance continued to strengthen educational partner engagement through intentional outreach, communication, and opportunities for feedback. Families were encouraged to participate in PAC/ELAC meetings and school events, and systems were in place to gather input and incorporate educational partner voice into decision-making. Survey data indicates that 98% of parents reported feeling encouraged to participate, exceeding the target of 85%. 31% of our responders who provided feedback are parents of a students with disabilities. Additionally, high levels of student and staff connection and safety further reflect a strong and inclusive school culture. There were no substantive differences between planned actions and implementation.

Overall Successes:

Assurance demonstrated strong outcomes in educational partner engagement across multiple measures. Parent participation in school events remained high, and survey data indicates that 98% of parents feel encouraged to participate, exceeding the target of 85%. Educational partner feedback gathered through PAC meetings further reflects strong engagement and trust within the school community. Parents consistently shared that they feel heard, supported, and valued, with comments such as “I feel supported,” “Teachers care,” and “My child is happy”. Feedback also demonstrated meaningful engagement, as families provided thoughtful input on academic supports, including requests for additional tutoring, small group instruction, and increased student engagement opportunities. Additionally, families expressed appreciation for whole-child supports such as health services and community partnerships, reflecting the school’s success in addressing both academic and social-emotional needs. These insights demonstrate that educational partner engagement extends beyond participation and reflects authentic collaboration and trust.

Overall Challenges:

While feedback remains overwhelmingly positive, parent input also highlighted opportunities to expand academic supports and student engagement activities, which will continue to inform future planning and improvements. Overall engagement remains strong, however PAC/ELAC participation declined to 600 participants, compared to higher participation in previous years. This indicates a need to strengthen consistent participation and deepen ongoing involvement from families. Moving forward, the school will focus on increasing sustained engagement, particularly in formal advisory groups and parent workshops, and ensuring that family voice continues to play a central role in school decision-making.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

There were no real material differences in the Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services, because actual expenditures were greater than budgeted expenditures and principally directed towards our English Language Learners, low-income, and foster youth students. We were able to meet our budgeted expenditures, as shown in the 2025-2026 Contributing Actions Annual Update table for estimated actual expenditures. This is true for the LCFF funds.

Action 4.1: Community/Parent Liaison and Meaningful School Activities

Effectiveness of Action: 3 – Effective

Metric: Participation Counts

Participation in school events remained strong, with 2,769 participants compared to an enrollment of 2,843, indicating a high level of engagement across the school community. These results demonstrate that providing multiple opportunities for involvement has been effective in increasing family participation.

Action 4.2: Translation and Outreach Services

Effectiveness of Action: 2 – Somewhat Effective

Metric: PAC/ELAC Participation

While PAC/ELAC participation declined to 600 participants compared to prior years, participation remains above the target of 250 participants. This indicates that while there is an opportunity to strengthen consistent engagement, the school continues to maintain strong overall educational partner involvement. While translation and outreach services have improved accessibility, these efforts have not yet resulted in consistent increases in participation. This action is considered somewhat effective, with a need to strengthen targeted outreach and engagement strategies.

Action 4.3: Educational Partner Engagement

Effectiveness of Action: 3 – Effective

Metric: School Survey Data

Survey data indicates that 98% of parents feel encouraged to participate, exceeding the target of 85%. Additionally, high levels of student and staff connection and safety reflect a positive and inclusive school culture. Educational partner feedback further supports these findings, with parents expressing strong satisfaction, trust, and confidence in the school's programs and support systems. Families reported feeling heard and supported, and actively contributed input to improve academic supports and student engagement opportunities. These results demonstrate that the school's efforts to engage educational partners are effective and should be maintained.

Action 4.2: Translation and Outreach Services

Assurance will continue to build on strong survey outcomes by creating additional opportunities for meaningful family input and leadership. Efforts will focus on increasing consistent participation in PAC/ELAC and strengthening systems for incorporating educational partner voice into decision-making. Additionally, the school will continue to respond to parent feedback by expanding academic supports, increasing student engagement opportunities, and ensuring that family input remains a central component in planning and continuous improvement efforts.

 - This amount is the total of the Planned Expenditures for Contributing Actions (LCFF Funds) column.
- **5. Total Planned Percentage of Improved Services**
 - This percentage is the total of the Planned Percentage of Improved Services column.
- **Planned Percentage to Increase or Improve Services for the coming school year (4 divided by 1, plus 5)**
 - This percentage is calculated by dividing the Total Planned Contributing Expenditures (4) by the Projected LCFF Base Grant (1), converting the quotient to a percentage, and adding it to the Total Planned Percentage of Improved Services (5).

Contributing Actions Annual Update Table

Pursuant to EC Section 42238.07(c)(2), if the Total Planned Contributing Expenditures (4) is less than the Estimated Actual LCFF Supplemental and Concentration Grants (6), the LEA is required to calculate the difference between the Total Planned Percentage of Improved Services (5) and the Total Estimated Actual Percentage of Improved Services (7). - **8. Total Estimated Actual Percentage of Improved Services (%)**
 - This amount is the total of the Estimated Actual Percentage of Improved Services column.
- **Difference Between Planned and Estimated Actual Percentage of Improved Services (Subtract 5 from 8)**
 - This amount is the Total Planned Percentage of Improved Services (5) subtracted from the Total Estimated Actual Percentage of Improved Services (8).

LCFF Carryover Table

- **10. Total Percentage to Increase or Improve Services for the Current School Year (6 divided by 9 plus Carryover %)**
 - This percentage is the Estimated Actual LCFF Supplemental and/or Concentration Grants (6) divided by the Estimated Actual LCFF Base Grant (9) plus the LCFF Carryover – Percentage from the prior year.
- **11. Estimated Actual Percentage of Increased or Improved Services (7 divided by 9, plus 8)**
 - This percentage is the Total Estimated Actual Expenditures for Contributing Actions (7) divided by the LCFF Funding (9), then converting the quotient to a percentage and adding the Total Estimated Actual Percentage of Improved Services (8).
- **12. LCFF Carryover — Dollar Amount LCFF Carryover (Subtract 11 from 10 and multiply by 9)**

- If the Estimated Actual Percentage of Increased or Improved Services (11) is less than the Estimated Actual Percentage to Increase or Improve Services (10), the LEA is required to carry over LCFF funds.

The amount of LCFF funds is calculated by subtracting the Estimated Actual Percentage to Increase or Improve Services (11) from the Estimated Actual Percentage of Increased or Improved Services (10) and then multiplying by the Estimated Actual LCFF Base Grant (9). This amount is the amount of LCFF funds that is required to be carried over to the coming year.
